FACTS	ACTS WHAT DOES INVESTORS TITLE INSURANCE COMPANY (ITIC) AND TITLE CENTER OF INDIANA, LLC (TCI) DO WITH YOUR PERSONAL INFORMATION?		
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.		
What?	 The types of personal information we collect and share depend on the product or service you have with us. This information can include: social security number and transaction history purchase history and mortgage rates and payments checking account information and wire transfer instructions When you are <i>no longer</i> our customer, we continue to share your information as described in this notice. 		
How?	All financial companies need to share customers' personal information to run their everyday business. What we do		
How does ITIC and TCI protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We will continue to enhance our physical, electronic and procedural safeguards as new technologies become available.	
How does ITIC and TCI collect my personal information?	 We collect your personal information, for example, when you: open an account or apply for insurance file a claim or provide your mortgage information show your government issued ID We also collect your personal information from others, such as credit bureaus, affiliates, or other companies. 	
Why can't I limit all sharing?	 Federal law gives you the right to limit only sharing for affiliates' everyday business purposes —information about your creditworthiness affiliates from using your information to market to you sharing for nonaffiliates to market to you State laws and individual companies may give you additional rights to limit sharing. 	
Definitions		
Affiliates	 Companies related by common ownership or control. They can be financial and nonfinancial companies. ITIC affiliates include companies with an Investors Title name; financial companies such as Investors Trust Company; and nonfinancial companies such as Investors Title Management Services, Inc. 	
Nonaffiliates	 Companies not related by common ownership or control. They can be financial and nonfinancial companies. ITIC and TCI do not share with nonaffiliates so they can market to you. 	
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you. ITIC and TCI do not jointly market with nonaffiliates.
